Rules and Regulations

1. No open dually style trailers will be permitted in the parade. Wheels must be constructed under the platform of the trailer being used. Exposed wheels are to be considered illegal use according to City Ordinance. **This Rule will be strictly enforced.**
2. All Units **MUST be decorated** with the exception of Public Officials / **ONLY ONE UNIT allowed per application**
3. No more than 50 walkers per individual entry will be allowed / No more than 25 walkers per float or vehicle will be allowed
4. All Units must be in Line-up by 6:00 p.m.
5. **NO CANDY OR OTHER ITEMS** may be thrown from a moving unit but can be passed out by walkers.
6. **Your Position Line-up Number will be given out at the MANDATORY safety meeting on Dec. 3, 2018, 7:00 pm @ Plant City High School Auditorium. A REPRESENTATIVE FROM ALL UNITS MUST ATTEND TO BE ADMITTED TO THE LINE-UP ON PARADE DAY!!! This rule will be strictly enforced beginning in 2018!**
7. Parade Line-up starts @ Collins & Alsobrook Street – heads North on Collins to Reynolds Street – right on Reynolds Street. The parade will end by the Plant City Court House. All floats and larger units will line up at Plant City Stadium.
