Rules and Regulations

1. No open dually style trailers will be permitted in the parade. Wheels must be constructed under the platform of the trailer being used. Exposed wheels are to be considered illegal use according to City Ordinance. **This Rule will be strictly enforced. NO Monster Trucks or Golf Carts will be allowed in the parade.**
2. All Units **MUST be decorated**, with the exception of Public Officials / **ONLY ONE UNIT allowed per application**
3. No more than 50 walkers per individual entry will be allowed / No more than 25 walkers per float or vehicle will be allowed
4. **All Motorized Units (Vehicles AND Floats) will line up at Plant City Stadium and must be in the lineup by 4:00 p.m.**
5. **NO CANDY OR OTHER ITEMS** may be thrown from a moving unit but can be passed out by walkers **age 12 or older.**
6. Your Position Line-up Number will be given out at the **MANDATORY** safety meeting on **Nov 30, 2020, 7:00 pm @ Sadye Gibbs Martin Community Center. A REPRESENTATIVE FROM ALL UNITS MUST ATTEND TO BE ADMITTED TO THE LINE-UP ON PARADE DAY!!! This rule will be strictly enforced!**
7. Parade Line-up starts at Plant City Stadium. The parade route starts at Collins & Alsobrook Street – heads North on Collins to Reynolds Street – right on Reynolds Street. The parade will end by the Plant City Court House. **All NUMBERED (1-80) motorized vehicles and floats will line up at Plant City Stadium (excludes LETTERED City, County or State officials).**

ACCEPTANCE OF ENTRY REQUIREMENTS, PARADE RULES, LIABILITY RELEASE AND HOLD HARMLESS AGREEMENT

1. For my organization, its owners, members successors and assigns, I do hereby release and forever discharge the Plant City Christmas Parade, Inc., its members, officers, agents and assigns from any and all causes of action, claims and demands of any type whatsoever, arising from or related to any damage, loss or injury, which may be sustained by my organization or its members, as result of participating in the Plant City Christmas Parade, Inc.
2. For my organization, its owners, members, successors and assigns, I do hereby agree to indemnity and hold harmless the Plant City Christmas Parade, Inc., its members, officers, agents from and against all actions, claims, demands and liabilities, loss damages and expense of any type, including attorney’s fees, which may be sustained by reason of my organization or its members, as a result of participating in the Plant City Christmas Parade, Inc.
3. My organization has advised its individual members that execution of this liability release is not only applicable to the organization, but the individual members of the organization.
4. This release extends to and includes all known, disclosed, undisclosed, unforeseen, unanticipated and unsuspected injuries, damages, losses, liabilities and the consequences thereof.
5. This release encompasses the Parade Rules, which are specifically incorporated by reference.
6. I have been specifically authorized to enter into this agreement on behalf of the organization seeking entry into the Parade. My organization is aware of the terms and conditions of the Entry Requirements, Parade Rules, Liability Release and Hold Harmless Agreement and agrees to be bound by the same. I will be responsible for my organization’s understanding of the same.
7. I have assigned a ‘group leader’ to represent my organization at line up and during the parade, and my ‘group leader’ agrees to be identified by wearing a lanyard that will be supplied by Plant City Christmas Parade, Inc. Lanyards will be given out at the MANDATORY safety meeting.
